Change Notification - 02 - 2019 – Update DIN and ISO Tri-Clamp Gasket range

Dear valued Business Partner,

with this letter we would like to inform you about our latest updates regarding the DIN and ISO Tri-Clamp gasket range.

What did we change?

We have completed our new DIN and ISO Tri-Clamp gasket range with updated, more competitive pricing for many items. In this process we also changed the item number and item description according to the relevant industry standards.

Why did we change the item numbers?

In Europe there are multiple industry standards which define the dimensions of Tri-Clamp gaskets. The most common standards shall be listed and explained in the following:

- The industry standard DIN 32676 is a framework standard that references the following standards:
 - DIN 11850 and DIN 10357
- (DIN 32676 Row A) (DIN 32676 Row B)

- ISO 1127
 - ASME BPE

(DIN 32676 Row C)

- SMS 3019
- ISO 2852

The above listed standards define specific Tri-Clamp gasket dimensions. In order to ensure consistency, we have adapted our item numbers and item descriptions accordingly. For *special sized gaskets* we have created additional item numbers to simplify the differentiation.

You can find all available gasket dimensions in our optimized *dimensional chart* including the respective industry standard. We have also created an *overview displaying the previous as well as the new item numbers and item descriptions*, so that the changes can be retraced and better understood.
