Change Notification - 2020 - 03 – Discontinuation Blank Lock Out Tag Outs

Dear valued Business Partner,

With this letter we would like to inform you about discontinuation of blank Lock Out Tag Outs

1. Type of Change

We, at Rubber Fab, have decided to remove the BLANK Lock Out Tags from our Lock & Label portfolio. This means that these items will no longer be available without the Rubber Fab logo and additional stamped identification numbers.

3. Reason for change

Rubber Fabs' Lock Out Tags are engraved with the Logo and we have now introduced this process as a standard, the Blank Lock Out Tags become obsolete.

4. Description of Change

In the future we will offer you the Lock Out Tags with Rubber Fab branding and stamped with a consecutive numbering system for identification. Also, the five different colors, blue, green, red, yellow and white will continue to be available.



Rubber Fab's Lock and Label are FDA Polysulfone tags with a stainless-steel wire. When properly installed, these color coded polysulfone tags cannot be opened, which can be great for accidental steam or product release. They are color coded tabs for Safety and Process Line Identification! Lock and Labels are versatile, tamper-resistant and tamper-evident seals for a multitude of applications.
