## Information - 2020 - 11 - Price Book 2021 letter

Dear Valued Customer,

Rubber Fab has been providing quality products to the sanitary industry for over 20 years. We work hard to create innovative product solutions for our customers as well as provide timely service on our products. As a company we strive to improve our efficiencies and control our costs on a daily basis but sometimes this is not enough to offset the challenges of doing business.

One such challenge has been the rising cost of raw materials from our many suppliers in the past year. We have also experienced increases in all of our freight charges as well.

We have been working hard to keep our pricing competitive for the market but with the challenges we face, we will be implementing a general 3% price increase across the board.

There are a few exceptions to this increase. Detectomer® and Tuf-Steel® Tri-Clamp® gaskets will not have an increase on the standard pricing. Those products launched in Europe in 2020, Next Generation Elastomeric TC gaskets and the European hose range will not have an increase. They will remain the same. Silicone Tri-Clamp® gaskets however will have a 5% increase. Gylon Bio-Line has a few exceptions for certain sizes where we have to align the pricing exceeding the general 3% price increase.

We would like to thank you for your understanding and look forward to our continued working relationship.
